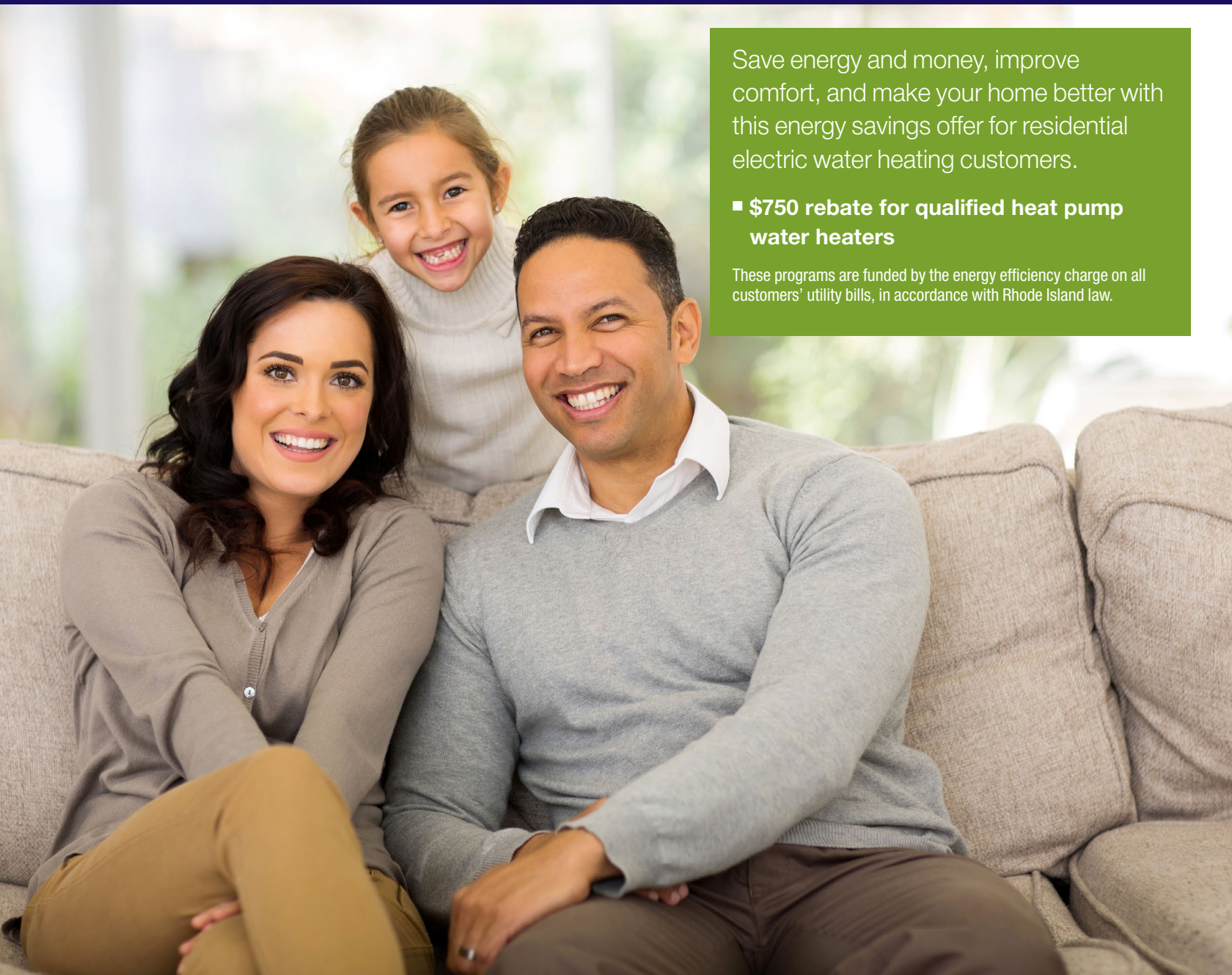

# Residential electric heat pump water heater rebates



Save energy and money, improve comfort, and make your home better with this energy savings offer for residential electric water heating customers.

- **\$750 rebate for qualified heat pump water heaters**

These programs are funded by the energy efficiency charge on all customers' utility bills, in accordance with Rhode Island law.

National Grid offers a rebate of \$750 for the installation of energy efficient electric heat pump water heaters when you are replacing an existing electric water heater, or installing a water heater up to 55 gallons in size for the first time (in a newly constructed home). A heat pump water heater is an electric storage tank replacement, and rebates are not available for replacement of oil, propane, or gas water heating units. A licensed plumber must install the unit in order for you to qualify for the rebate, and only certain equipment models are eligible. There are also restrictions about where the unit can be installed to ensure that it operates at its maximum efficiency. ## TO APPLY:

1. Verify that the electric heat pump water heater you will be purchasing qualifies for a rebate by consulting with a licensed plumber. Eligible equipment is also listed at [www.ngrid.com/ri-hpwh](http://www.ngrid.com/ri-hpwh).
2. Purchase a qualified electric heat pump water heater and have a licensed plumber install it. The equipment must be installed at a property with an active National Grid residential electric account.
3. Obtain an invoice from your contractor/plumber. The invoice must contain the following information: equipment make and model numbers, size (in gallons), date and location of installation, total installation cost, and contractor's name and address. It must indicate "paid in full" or "zero balance."

  - This application, completed accurately and legibly
  - Dated receipt with complete model information
  - A dated invoice from your contractor providing the information listed above in step 3

Rebate form and required documentation must be postmarked or submitted online within 60 days of equipment installation date, or by January 31, 2017, whichever comes first.

**IMPORTANT! Photocopy your entire submission for your records. You could be required to mail these photocopies. Offer valid on equipment purchased and installed between January 1, 2016 and December 31, 2016 (subject to funding availability).**

**All submissions must be postmarked or submitted online by January 31, 2017. Please allow 6-8 weeks for processing. ## TERMS & CONDITIONS

Heat pump water heater must be installed by a RI licensed contractor and/or plumber within National Grid's electric service area. It must be UL listed; installed in accordance with the National Electric Code and manufacturer's specifications; and conform to all applicable municipal, state and federal codes, standards and regulations, as well as program requirements. Must be ENERGY STAR® certified with an Energy Factor (EF)\* of 2.3 or greater and have a minimum 10 year manufacturer's warranty. Rebate amount not to exceed the cost of equipment (excluding sales tax and all installation costs). Eligible heat pump water heaters can be found on [www.ngrid.com/ri-hpwh](http://www.ngrid.com/ri-hpwh). Program is subject to change without prior notice, including rebate levels. \*Energy Factor (EF) is the ratio of useful energy output from a water heater to the total amount of energy delivered to the water heater. The higher the EF is, the more efficient the water heater.

Rebates are available to eligible National Grid residential electric customers only. One electric account number per form. Some restrictions may apply. Rebate offers are subject to change without notice. Please review terms and conditions. Form must be completed in its entirety.
